THE DEPUTY GENERAL COUNSEL (MISCELLANEOUS PROVISIONS) **ORDINANCE 2024**

Ordinance No. 4 of 2024

An Ordinance to amend existing laws of the Territory following the creation of the office of Deputy General Counsel.

Citation and commencement.

This Ordinance may be cited as the Deputy General Counsel (Miscellaneous Provisions) Ordinance 2024 and shall come into force forthwith.

Amendment of existing laws.

For each of the laws specified in the Schedule, the items listed in Column 1 shall be replaced, amended or otherwise dealt with in accordance with the corresponding items in Column 2.

Column 1	Column 2
The Courts Ordinance 1983 Section 49(3)	Subsection (3) of the Section 49 is amended by adding the words ", Deputy General Counsel," between the words "General Counsel" and ""or Principal Legal Adviser".
The Interpretation and General Provisions Ordinance 1993 Section 8	Section 8 is amended by repealing the definition of "General Counsel" and replacing it with — "the "General Counsel" means the person for the time being appointed by the Commissioner to hold, to act in, the office of the General Counsel to the Government of the Territory and includes any person for the time being performing the functions of that office."
The Law Revision Ordinance 2015 Section 2	The definition of "General Counsel" in section 2 is repealed.

THE DESIGNATION OF ACTING GENERAL COUNSEL ORDER 2024

S.I. No. 4 of 2024

- 1. In exercise of the powers in that behalf under section 7 of the British Indian Ocean Territory (Constitution) Order 2004, the Commissioner appoints Deputy General Counsel to the position of Acting General Counsel during any period when
 - (a) a person has not been appointed to the office of General Counsel, or
 - (b) the General Counsel is unable for any reason to discharge his or her functions of the office.
- 2. The Acting General Counsel shall hold all powers, and carry out all duties and responsibilities of the General Counsel.
- 3. The Designation of Acting General Counsel Order 2014 is hereby repealed.
